- 2) The Document Verification is scheduled on 22.02.2023 at Railway Recruitment Board, Muzaffarpur and the reporting time is 02:00 PM.
- 3) SMS/email alert is being sent to candidate's registered mobile/email ID for downloading their e-call letter from RRB's website.
- 4) Candidate is advised to read the detailed instructions given in the DV e-call letter carefully and bring all the required certificates/documents in original.
- 5) The candidates called for DV should produce all the original documents along-with two set of photo copies in A4 size paper as detailed in the CEN and e-call letter issued for DV.
- 6) Those candidates called for DV may note that after completion of DV will be sent for Medical Examination at the nominated Railway Hospital located in the jurisdiction of concerned RRB on the next day of the DV. The candidate is required to come prepared to stay for 3-4 days accordingly. Candidate has to pay the prescribed medical fee of Rs. 24/- only. Accordingly, candidate has to come prepared for DV and Medical Examination.
- 7) Candidates are advised to bring Six (06) passport size color photographs not more than one month old. Candidates will also bring Candidate's foil of e-call letter of CBT 1, CBT 2 & CBTST wherever applicable.
- 8) In case of verification in spelling in name/father's name in the online application and original certificates/documents, on the date of verification, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate(s) is one & same.
- 9) No additional time will be given to the candidates who fail to produce their original certificates/relevant affidavit on the scheduled date of DV and the candidature of such candidates is liable to be forfeited/cancelled
- 10) **BLOCK DATE FOR ABSENTEE CANDIDATES (28.02.2023):** For the candidates who fail to report for the Document Verification on the regular date assigned to them in their call letter with valid reasons, a second and final chance to attend the Document Verification is kept on the block date. It must be noted that failure to report for the Document Verification on the scheduled date (22.02.2023) will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a University/Government examination or due to sickness of the candidate. No other reason for absence will be considered. In such cases only, the candidates will be provided the last and final opportunity to appear in the Document Verification on **28.02.2023 at 09.00 HRS** at the office of RRB, Muzaffarpur. No fresh e-call letter will be sent for this purpose and the candidates can attend with the same e-call letter downloaded for the regular Document Verification.

- 11) The candidature of the shortlisted candidate is purely provisionally and is liable to be cancelled at any stage of recruitment or thereafter. In case of any inconsistency/deficiency/discrepancy detected in the information furnished by him in online application or any malpractice on his part coming to the notice at any stage of the recruitment process or thereafter.
- 12) It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical Examination does not entitle him in any way to an appointment in the Railways.
- 13) While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidate.
