In terms of Railway Board's letter No. 2022/E(RRB)25/08 Vol 02 dt. 13.06.2024 & 04.11.2024 and demand of Additional Indent for filling up 01 Additional Vacancy vide PLW, Patiala's letter No. PLW/P/Rectt./Availanility of Standby Candidates dated 18.11.2024, the name of following 01 waitlisted/standby candidate (Roll No. given below) of Technician category (category No. 34) of CEN 01/2018 is being recommended to Patiala Locomotive Works/Patiala for further necessary action. These candidates shall be required to give an undertaking that they will undergo fresh Medical Examination to ascertain their Medical fitness (Suitability) for the Post of Technician categories and in case they are not found fit, their candidature will not be considered. Medical Examination will be conducted by Patiala Locomotive Works/Patiala as per extant procedure and candidates should submit their undertaking at the time of being sent for fresh Medical Examination.

Based on the performance of candidate in the 1st Stage Computer Based Test conducted from 09.08.2018 to 31.08.2018 and on 04.09.2018, 2nd Stage Computer Based Test conducted from 21.01.2019 to 23.01.2019 and on 08.02.2019, and the verification of the documents(DV) of candidates held from 16.06.2019 to 03.07.2019 and absentee DV on 06.07.2019 and on being found medically fit, the following 01 candidate from Extra List have provisionally been empanelled strictly as per merit for the post of Technicians Grade III, cat No. **34** under CEN – 01/2018 against demand of Additional Indent by Patiala Locomotive Works/Patiala. Their name is being forwarded to Principal Chief Personnel Officer, Patiala Locomotive Works/Patiala. Further course of action on their appointment will be taken by Principal Chief Personnel Officer, Patiala Locomotive Works/Patiala after due verification & ensuring fulfillment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Qualification, Date of Birth, Caste, Past Character/Antecedents/Affidavits where necessary etc. according to the Centralized Employment Notice No. 01/2018 and corrigendum issued thereto from time to time for which the candidates will be informed individually by the Patiala Locomotive Works/Patiala. Candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.
